Preparation:

1. Mix phase A1 (If possible use a three roll mill to distribute the pigments homogeneously).
2. Add phase A2 and melt A1/A2 to approx. 80/85°C.
3. Add perfume/phase A3 right before filling the lipsticks into the molds.
4. Put the molds into the refrigerator/freezer und remove the lipsticks after 30 minutes.
